In staying with our long-term capital improvement plan as to what infrastructure needs to be repaired, replaced, or added over the next 10 years, we are currently working on improvements to the Sageport Wastewater Treatment Plant and replacing aging equipment at the Bannock Lift Station.

Additionally, construction along Country Club Drive, for the water-line loop to provide adequate fire flow along the northern portion of Perry Park, will begin in June and is expected to be completed by mid-August. During construction, we will have BIG equipment for grading, trenching and laying pipe. In order to ensure everyone's safety during construction, Country Club Drive will be temporarily closed to thru traffic. We strongly discourage walking and biking on this section of Country Club Drive during this time. Thank you for your help in getting this project done safely and as timely as possible. An irrigation permit is required for all new irrigation and landscape designs. For the initial installation of your backflow prevention device or those who already have an irrigation permit, please remember to have your certified tester send the results of your backflow prevention assembly test to ppwsd@comcast.net. That way we keep the water flowing only one way and water quality in the Perry Park community remains safe.



Annual Water Quality Report



You should have received our annual Consumer Confidence Report (CCR) in your mailbox. The CCR is an annual water quality report that all public water systems are required to provide. It is based on the 1996 Amendments to the Safe Drinking Water Act and the right-to-know provisions of that Act. Each customer of the Perry Park Water and Sanitation District (PPWSD) has the opportunity to review it any time on the PPWSD website. The CCR was designed to help the consumer make informed choices about the water they drink and to know what contaminants, if any, are in their drinking

water, and how these contaminants may affect their health.

Your water quality is important to us, which is why we employ some of the most qualified operators in Colorado. These operators are responsible for the ongoing testing and treatment of your drinking water. We're pleased to announce the drinking water provided to the residents of Perry Park continues to meet and exceed the EPA's strict drinking water quality standards. Never Flush the Drugs

It's dangerous to flush your old and expired medications down the drain or the toilet. You also don't want to throw them away in the trash. Instead, please drop them off at a drug take-back location where experts will safely destroy the medications.

The Douglas County drug take-back effort aims to provide a safe, convenient, and responsible way to dispose of prescription drugs, while also educating the public about the potential abuse of medications. Household Chemical Roundup



A lot of common household products, such as oil-based paint, degreasers, and garden chemicals, may be hazardous to people's health and the environment if disposed of improperly. Be sure to read the product labels

to safely store, use, and dispose of chemicals. When these chemicals are not used up entirely, they become household chemical waste and must be disposed of properly or it can harm sanitation workers, create problems in sewage treatment plants and landfill, or pollute the water or air. That's why the Tri-County Health Department organized Household Chemical Roundups for Douglas County. There are two more of these Roundups this year with the hours from 9am – 3pm. You may have read about electrically-driven water meters in the press that may be associated with fire hazards. That's why it's important to know that here in Perry Park, we use water meters that were chosen for their reliable function and remote-read capability. They are sensitive with measuring a wide range of water flows for a variety of residential applications. Over the years they have proven to be accurate, reliable and sustainable residential water meters that are safe to use because they operate off of batteries and do not require any electricity. While we are replacing some older models that are the clicker-type of remotes, none of them require electricity.

Don't Be Left Out!

While we try to prevent issues such as water shortage or line breaks, we also must conduct preventative measures to help ensure water quality and system maintenance that can require temporary water shut-offs.
